My Dear Parishioners,

This past June marked the fifth anniversary of my appointment as your pastor. *Tempus fugit!* So much has happened in that period of time. We are now in our fourth year in the Church and Chapel. It has been a tradition in the fall season of each year to take the time and reflect on the meaning of being a stewardship parish and tithing community. Through your generosity and sacrificial outpouring of time, talent and treasure our parish community continues to flourish. This is so evident through our worship as well as the many organizations and activities which serve our spiritual, social and community needs.

This year the Evangelization Committee was formed from the Pastoral and Finance Councils to give specific direction to fulfilling our parish strategic plan and promoting initiatives which I am confident will bear much fruit. The committee has made its vision statement, "A vibrant, welcoming parish family dedicated to growing disciples and making church matter." One has only to notice Mass attendance and to see the activity taking place in our spacious narthex, or to read the parish bulletin, website or parish app, to learn of the wonderful progress and growth of our faith in action.

While the weekly collection remains a primary source of parish operating funds, the Annual Stewardship Appeal augments these resources to enable us to fully cover fixed costs and to accomplish the goals and objectives as proposed in the parish strategic plan. Be assured that with the collaboration of the Pastoral Council and the Finance Council, I am able to ensure the greatest care is exercised in the stewardship of all parish funds.

In consultation with the Parish Finance Council and the Parish Pastoral Council, I am pleased to enclose with this letter a copy of the summary of the **Annual Parish Financial Report** for fiscal year ending June 30, 2014. The Finance Council will be giving a short presentation, clarifying further information in the report, at all the masses on Stewardship Weekend, October 11 and 12, which is also the weekend of our annual Ministry Fair.

While we are doing well in a number of key areas, our day to day expenses continue to rise – no different than what you are experiencing in your homes. We still face the daunting challenge of repayment of our \$12.5 million loan and associated interest to the Archdiocese. I am happy to report a number of positive trends including: continued operating gain, a fifth year of improved weekly collections, an appropriate and responsible operating budget for the present fiscal year, a strategic plan which includes the repayment of our loan as well as the building of the Parish Life Center, which will be completely self-funded. More information about the status and progress of the PLC will be given in the presentation.

May I ask that you please fill out the enclosed Census Report and provide us with the requested information concerning your family household which will help us to update and keep accurate records. This will be most helpful at this time as we continue to see positive signs of growth. Even if there are no changes, we ask that you make a notation on the form and return it to the parish office. If you are unable to be present for the weekend of the Parish Ministry Fair, you may mail your census and stewardship offering to the parish office; otherwise, may I ask that you place them in the special second collection on Stewardship Weekend.

I look forward to seeing you on Stewardship Weekend and at our Parish Ministry Fair. I truly appreciate the great sacrifice you make in your dedication and support of Our Lady of Guadalupe Parish. On behalf of Father Robert Ianelli, Father Walter Quinn and Deacon Robert Brady, be assured of a remembrance in our daily prayers of thanksgiving for you and your intentions. May the Blessed Mother, Our Lady of Guadalupe, watch over and protect you and your loved ones.
